BYLAW 0379, 2000

A bylaw to amend Fraser Valley Regional District Special Events Bylaw No. 0111, 1997

WHEREAS the Regional District is authorized by Order-in-Council 1961/70 Supplementary Letters Patent, to regulate a function, gathering or entertainment in all areas of the Regional District;

AND WHEREAS the Regional Board has deemed it necessary to amend the area of application for the Special Events Bylaw No. 0111, 1997;

NOW THEREFORE the Board of the Fraser Valley Regional District in open meeting assembled enacts as follows:

1. CITATION

This Bylaw may be cited for all purposes as the "Fraser Valley Regional District Special Events Amendment Bylaw No. 0379, 2000".

2. ENACTMENT

That Section 4 of the Fraser Valley Regional District Special Events Bylaw No. 0111, 1997 be deleted and the following substituted therefore:

"4. Notwithstanding any other provision of this bylaw, this bylaw shall not apply to:

- (i) any annual celebration, fair, fund raising event or public assembly organized by, or sponsored by, a duly constituted and recognized ratepayers' organization, a duly constituted and recognized community association, or duly constituted fire department operating within the boundaries of the Fraser Valley Regional District; and/or
- (ii) any congregation, gathering or event that is to take place in any permanent building or permanent structure or permanent facility lawfully existing on the date of adoption of this bylaw and affixed to land lawfully zoned by the authorities having jurisdiction for


the holding of such congregation, gathering or event within the boundaries of the Fraser Valley Regional District; and/or

(iii) any event taking place at an established ski resort lawfully operating within the boundaries of the Fraser Valley Regional District and in accordance with the British Columbia Asset and Lands Corporation "Commercial Alpine Ski Policy", as amended from time to time. These uses and events include but are not limited to:


- (a) any and all forms of downhill skiing;*
- (b) cross-country skiing;*
- (c) tubing parks;*
- (d) snow board terrain parks;*
- (e) uses set forth in the License of Occupation issued by the Province of B.C. for the area commonly known and referred to as "Hemlock Valley Resort", and other such uses as may be set forth under an extension to said License of Occupation; and/or*
- (g) other uses as may be set forth under an amendment to the British Columbia Asset and Lands Corporation "Commercial Alpine Ski Policy". "*
