BYLAW NO. 418

A bylaw to amend the Regional District of Fraser-Cheam Bylaw No. 103, 1978, the Mobile Home Park Bylaw.

WHEREAS the Regional Board of the Regional District of Fraser-Cheam has deemed it advisable to amend the Mobile Home Park Bylaw No. 103, 1978;

NOW THEREFORE the Regional Board of the Regional District of Fraser-Cheam in open meeting assembled enacts as follows:

TEXT AMENDMENT

- 1. That Section 2.02(8) be deleted and the following substituted therefor:

"(8) Fees

- (a) Each initial application for a mobile home park permit submitted shall be accompanied by an application fee of Thirty (\$30.00) Dollars for the first mobile home space and Fifteen (\$15.00) Dollars for each additional mobile home space shown in the mobile home park plan, up to a maximum of One Thousand (\$1,000.00) Dollars.
- (b) Where a mobile home park is developed in phases, each stage shall be treated for the purpose of calculating the fees payable as a new and separate application except that a maximum of Five Hundred (\$500.00) Dollars shall apply to each application after approval of the initial phase.
- (c) Each application for renewal of a mobile home park permit shall be accompanied by an application fee of Five (\$5.00) Dollars for each mobile home space shown in the mobile home park plan.
- (d) The charge for permits for the construction of buildings or structures in the mobile home park shall be the same as specified in any building bylaw applicable to the Electoral Areas of the Regional District enacted pursuant to Sections 734 and 818 of the Municipal Act.
