Glenwood is a licensed residential care facility funded by Fraser Health. This family-owned and operated facility contains 37 complex care beds. The centre is connected to Logan Manor, as they share laundry and kitchen facilities. There is also a Day Care program that operates out of Glenwood from Monday to Friday.

Logan Manor is an assisted living facility with some provision for nursing care if needed. It contains 32 assisted living apartments - 30 one bedroom units and 2 two bedroom units. Some of the units are subsidized through Fraser Health and BC Housing.

To qualify, families must have a gross household income of \$35,000 or less, have at least one dependent child, and have been employed at some point over the last year.
