BYLAW NO. 1393, 2016

**A bylaw to amend the Fraser Valley Regional District Board and Committee
Procedures Bylaw No. 1305, 2016**

WHEREAS the Board of Directors of the Fraser Valley Regional District deems it advisable to amend *Fraser Valley Regional District Board and Committee Procedures Bylaw No. 1305, 2015* in keeping with changes to the *Local Government Act, RSBC 2015 Ch 1*;

THEREFORE the Board of Directors of the Fraser Valley Regional District enacts as follows:

1. CITATION

This bylaw may be cited as the *Fraser Valley Regional District Board and Committee Procedures Amendment Bylaw No. 1393, 2016*.

2. ENACTMENTS

That Fraser Valley Regional District Bylaw No. 1305, 2016 is amended by:

- 2.1 Under Section 2 [Definitions], deleting the definition of **Inaugural Meeting of the Board** and replacing it with the following:

"Inaugural Meeting of the Board means the first meeting of the Board in any given year, in this case, each November.";

- 2.2 Under Section 2 [Definitions], deleting the definition of **Inaugural Meeting of Standing and Select Committees** and replacing it with the following:

"Inaugural Meeting of Standing and Select Committees means the first meeting of a Standing or Select Committee in any given year, in this case, each December.";

- 2.3 Deleting Section 4.1.1 in its entirety and substituting it with the following:

"4.1.1 An Inaugural Board Meeting shall be convened during the month of November at such time as shall be established by the person responsible for corporate administration.";

- 2.4 Deleting Section 5.2.2 in its entirety and substituting it with the following:

"5.2.2 An Inaugural Meeting of a Standing Committee shall be convened during the month of December in any given year at the regularly scheduled meeting location and time.";

- 2.5 Deleting Section 5.3.2 in its entirety and substituting it with the following:

"5.3.2 An Inaugural Meeting of a Select Committee shall be convened during the month of December in any given year at the regularly scheduled meeting location and time."

3. SEVERABILITY

If a portion of this bylaw is found invalid by a court, it will be severed and the remainder of the bylaw will remain in full force and effect.

4. READINGS AND ADOPTION

READ A FIRST TIME THIS 21st day of September, 2016

READ A SECOND TIME THIS 21st day of September, 2016

READ A THIRD TIME THIS 21st day of September, 2016

ADOPTED THIS 21st day of September, 2016
