

**FRASER VALLEY REGIONAL DISTRICT
BYLAW NO. 1713, 2023**

A bylaw to amend the boundaries of the Electoral Area Animal Control Service Area

WHEREAS the Fraser Valley Regional District Board of Directors (“the Board”) wishes to amend the boundary of the Service Area established by *Fraser Valley Regional District Electoral Areas Animal Control Service Area Establishment Bylaw No. 1233, 2013*;

AND WHEREAS consent on behalf of the electoral participating areas of the Fraser Valley Regional District has been obtained;

THEREFORE the Board enacts as follows:

1) CITATION

This bylaw may be cited as *Fraser Valley Regional District Electoral Area Animal Control Service Area Amendment Bylaw No. 1713, 2023*.

2) ENACTMENTS

Fraser Valley Regional District Electoral Areas Animal Control Service Area Establishment Bylaw No. 1233, 2013 is hereby amended by:

- a) Extending the boundaries of the Electoral Area Animal Control Service Area to include Electoral Areas B and C in their entirety.
- b) Deleting Section 2. b) in its entirety and replacing it with the following:

“2.b) The boundaries of the Electoral Area Animal Control Service Area shall be the boundaries of Electoral Areas B, C, D, E, G and H of the Fraser Valley Regional District”;
- c) Deleting Section 2.c) in its entirety and replacing it with the following:

“2.c) The service area shall include the following participating areas: Electoral Areas B, C, D, E, G and H of the Fraser Valley Regional District”;
- d) Deleting Section 2.e) in its entirety and replacing it with the following:

“2.e) The maximum amount that may be requisitioned annually for the entire service established by this bylaw shall be \$150,000.”;

- e) That the provisions of all bylaws that are now in effect with regard to the establishment and amendment of the Electoral Area Animal Control Service Area remain in full force and effect.

3) SEVERABILITY

If a portion of this bylaw is found invalid by a court, it will be severed and the remainder of the bylaw will remain in effect.

4) READINGS AND ADOPTION

READ A FIRST TIME THIS 27th day of July, 2023

READ A SECOND TIME THIS 27th day of July, 2023

READ A THIRD TIME THIS 27th day of July, 2023


