RGS Monitoring Program

A Regional Growth Strategy (RGS) is a policy and planning framework that's used to guide and coordinate the activities of local and provincial governments in relation to long-term regional growth.

Monitoring and evaluating the progress and issues related to RGS goals and policies is an important aspect of RGS implementation.

The RGS monitoring program:

- » Provides data used for regional decision-making
- » Highlights regional opportunities, challenges, and priorities
- » Provides information about indicators associated with RGS goals
- » Measures long-term trends data from a variety of sources

Active Transportation Network Plan

The FVRD has successfully secured funding to develop an Active Transportation Network Plan. Active transportation is defined as nonmotorized modes of transport such as walking, cycling, rollerblading, e-bikes and e-scooters, etc.

The plan will incorporate existing and planned regional trails and integrate with municipal networks where possible to create a strong network that enhances both commuting and recreational trips for all active modes. Once an Active Transporation Network Plan is in place, the FVRD will be eligible to apply for infrastructure funding to construct the proposed network trails.
