VOTER REGISTRATION

Registration will take place at the time of voting. Voter requirements:

- 18 years of age or older on general voting day (Oct 17, 2026)
 - Canadian citizen
 - resident of BC for at least 6 months before the day of registration
 - EITHER: A resident of the Electoral Area
- OR**
- A registered owner of real property in the Electoral Area for at least 30 days before the day of registration,
- not otherwise disqualified by law from voting, and
 - entitled to vote and have not previously voted in this election.

In addition to the above, non-resident property owners (NRPEs) must:

- not be entitled to register to vote as a resident in the Electoral Area;
- all be individuals registered on title. If there is a corporation registered on title, none of the owners are eligible to vote as an NRPE;
- only register to vote in relation to one property in the Electoral Area;
- be a registered owner of real property as described in Section 66(4) of the *Local Government Act*.
- register only one of the owners to vote on behalf of that property and obtain written consent from the majority of those on title. Consent forms can be obtained prior to the time of voting from www.fvrd.ca/elections or by contacting elections@fvrd.ca

IDENTIFICATION REQUIREMENTS

Resident electors: 2 pieces of identification (at least one with a signature; picture not required) which should together prove both residency and identity.

Non-resident property electors: 2 pieces of identification to prove identity (at least one with a signature; picture not required) AND proof that you are entitled to register in relation to the property (title search, tax notice).
