**1. Can you confirm the playground layout and orientation on the site?**

**2. Is the contractor expected to deal with security fencing?**

Yes.

**3. Can there be an updated plan that includes the swings?**

Attached.

**4. Is finishing the grass area a part of the job?**

The site should be level and clear of debris and ready for finishing at a later date.

**5. Can you confirm what equipment should be salvaged?**

The FVRD will be keeping the spinner bowl, the rocker feature and the swing set, and will be storing them to use in an upcoming project.

**6. Do all the play chips need to be replaced?**

New certified play chips are required for the entire park to be installed according to CSA standards.

**7. Is the playground and swing set CSA certified?**

Yes. The swing is a custom design to meet community specifications. All equipment is CSA certified and must be installed to the specifications. The contractor must complete and provide a CSA certified inspection upon completion of the playground. A copy of valid CPSI certification is required with submission of a proposal.

**8. Does the jeep need to be refinished?**

The contractor should be prepared to have the jeep refinished before having it re-installed.

**9. What are the timelines?**

The equipment is anticipated to be coming by the end of May. Ideally the old equipment is disposed of, and the play structure is completed by the end of June 2025.

**10. Where is the equipment being stored?**

We would like for the equipment to be shipped to the successful proponent who will arrange and be responsible for transportation to the site.

**11. Final Addenda**
