Reporting to the Manager of Environmental Services, you will be directly contributing to the FVRD's environmental outreach and education efforts. Your enthusiasm, effective communication and research skills, critical thinking, and ability to write reports and memos will serve you well in this position. If you are an aspiring professional who loves working with the community, cares for the environment, and can work both independently and as part of a team, you will fit right in.

The candidate must have:

- » A degree in Environmental Sciences or a related field with a good understanding of, and preferably some experience working with environmental issues relating to the various environmental files handled by this department, or equivalent combination of education and experience.
- » Knowledge of local government service delivery and municipal waste and air quality management practices is preferred, and knowledge of legislation, policies and procedures pertaining to Regional Districts, would be an asset.
- » Preferably experience in project implementation, conducting research and feasibility studies.
- » Strong communication and interpersonal skills including the ability to express thoughts and ideas clearly, and converse with a wide range of people including technical consultants, elected officials, staff, and the general public to provide advice
- » Excellent writing skills, with the ability to write in a clear and concise manner, and to assist with the preparation of technical and administrative reports.
- » Ability to establish and maintain positive and effective working relationships with consultants, contractors, stakeholders, senior staff, co-workers, team members, elected officials, advisory bodies and the public.
- » A valid Driver's Licence.

The start rate for these full-time union positions is \$28.77 per hour plus a comprehensive benefits package. Upon successful completion of the required six-month probationary period, the rate will increase to \$33.84 per hour.
