All requests to adjust a water utility invoice will be reviewed by the FVRD Manager of Operations and, if approved, an adjustment will be made to the amount owing. Requests for invoice adjustments can only go back two billing periods. Prior to the approval of an invoice adjustment the FVRD must be satisfied that the leak has been repaired. Please provide as much documentation as possible and keep all receipts as proof of work completed.
